The Division of Public Utilities (Division) makes this filing pursuant to the Public Service Commission of Utah's (Commission) Notice of Status Report issued September 26, 2018 (Notice). The Commission ordered the parties, jointly or singly, to provide a status update by November 23, 2018.

Despite Pacific Energy & Mining Company's (PEMC) repeated assurances that a draft of the revised Policy and Procedural manual would be made available to the Division so that it could assist PEMC in remedying deficiencies previously noted in this docket, the Division has not received such a draft. The Division has had no communication from PEMC since on or about November 15, 2018.

Given PEMC's inaction and the Notice's request for a hearing date, the Division proposes that the Commission schedule a hearing on the merits, including the imposition of penalties, during the week of December 17, 2018.
