MOTION FOR AN ORDER REQUIRING

REVIEW OF DOCUMENTS

ISSUED: July 26, 2019

On July 10, 2019, Pacific Energy & Mining Company (PEMC) filed a Motion for an Order Requiring the Division of Public Utilities (DPU) to Review PEMC's Documents In Person ("Motion"). That same date, the DPU filed a response, representing the DPU and PEMC had scheduled a meeting for July 16, 2019 and that an order was unnecessary. PEMC did not file a timely reply. In the absence of a reply and based on the DPU's representations, the Public Service Commission (PSC) concludes no basis exists to issue the order PEMC requests. The Motion is denied.

Based on the DPU's and PEMC's most recent filings, it appears the parties have differences of opinion as to whether PEMC, or the pipeline's current operator, has fully complied with the PSC's Hazardous Facility Order ("HFO") and all applicable pipeline safety requirements. Additionally, given that the DPU represented the parties intended to meet on July 16, 2019, the PSC understands the circumstances to be evolving as the parties work to implement the HFO. If the DPU believes additional violations exist, the DPU may file a request for agency action to initiate a proceeding to adjudicate the alleged violations. If the DPU believes circumstances exist that render the pipeline imminently unsafe or that injunctive relief from a court of appropriate jurisdiction is otherwise necessary, the DPU may file a request with the PSC

to seek such relief, outlining the actions the DPU believes a court should compel PEMC to take to render the pipeline compliant.
