NOTICE OF COMPLAINT AND COMMENT PERIOD

ISSUED: March 12, 2019

On September 27, 2018, Brett Robinson and Brad Crookston ("Complainants") filed a formal complaint ("Prior Complaint") in Docket No. 18-057-18 (the "Prior Docket"). On January 23, 2019, the Public Service Commission ("PSC") issued an Order Dismissing Complaint ("Order") in the Prior Docket, finding and concluding that the line extension for which Complainants sought an exception had already been completed and that no allegation existed DEU had violated its policy or another provision of rule or tariff. The Order dismissed the Prior Complaint without prejudice. On January 25, 2019, Complainants submitted correspondence to the PSC in the Prior Docket, urging reconsideration. The PSC treated the January 25 correspondence as a request for review or rehearing pursuant to Utah Code Ann. § 54-7-15 and denied the request on the same grounds enumerated in its earlier Order.

On February 21, 2019, Complainants submitted additional correspondence ("New Filing") to the PSC. The New Filing argues DEU violated its policy to treat customers fairly and equally and further violated Utah Code Ann. § 54-3-1 by requiring an unjust, unreasonable, and inefficient route for its gas main extension.

Because the Prior Complaint has been fully adjudicated before the PSC and because the New Filing contains new and additional allegations not made in the Prior Complaint, the PSC will treat the New Filing as a new complaint. The PSC has opened Docket No. 19-057-09 for the purpose of adjudicating it.
