Pursuant to Section 5.07 of Questar Gas Company dba Dominion Energy Utah's ("Dominion Energy" or the "Company") Utah Natural Gas Tariff No. 500, Dominion Energy Utah applies to the Public Service Commission of Utah ("Commission") for an order approving the RNGT Service Agreement –RNGT001 between Dominion Energy Utah and Fleet Saver, LLC dated April 2, 2019 ("Fleet Saver Agreement") and in support states as follows:

1. Dominion Energy Utah, a Utah Corporation, is a public utility engaged in the distribution of natural gas primarily to customers in the states of Utah and Wyoming. Its Utah public utility activities are regulated by the Commission.

2. The Fleet Saver Agreement is subject to approval by the Commission. The Fleet Saver Agreement is not attached to this Application but is attached to the Confidential Testimony of Kelly B Mendenhall, which is filed herewith. Dominion Energy Utah requests that the Confidential Testimony of Kelly B Mendenhall and the attachments thereto be treated as confidential pursuant to Utah Admin. Code R746-1-601 *et seq.*

3. Approval of the Fleet Saver Agreement is just, reasonable and in the public interest.

WHEREFORE, Dominion Energy Utah respectfully requests that the Commission enter an order approving the Fleet Saver Agreement.
