Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-1-108, Petitioner Magnum Energy Midstream Holdings, LLC (“Magnum”) hereby petitions for leave to intervene in this docket.

In support of this Petition, Magnum states as follows:

1. Magnum is developing various salt storage-related projects at the Western Energy Hub located near Delta, Utah. Dominion Energy Utah (DEU) asserted a need for supply reliability and peak-hour services and considered natural gas storage and related services as possible solutions. DEU submitted a request for proposals (RFP) to address those needs and Magnum submitted a bid in response to that RFP.

2. The legal rights and interests of Magnum may be substantially affected by this proceeding.

3. Magnum requests intervention in order to ensure that DEU, interested parties, and the Commission all clearly understand the nature, flexibility, benefits and costs of its gas storage options. Magnum seeks to intervene for the purpose of protecting its interests.

4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Magnum to intervene.
