# ORDER DENYING REQUEST FOR REVIEW AND REHEARING

ISSUED: August 30, 2019

### **BACKGROUND**

On August 1, 2019, the Public Service Commission of Utah (PSC) issued an order ("Order") dismissing the formal complaint in this docket filed by Alan Kruckenberg Construction, Inc. ("Complainant") against Dominion Energy Utah (DEU). Thereafter, on August 12, 2019, Complainant filed a request for review and rehearing ("Request"). Complainant's Request did not include a certificate of service or other indication that the Request had been mailed to DEU. DEU has not responded to the Request.

# FINDINGS, CONCLUSIONS, AND ORDER

Review or rehearing of our Order is governed by PSC statute<sup>1</sup> and the Utah Administrative Procedures Act (UAPA).<sup>2</sup> Under sections 63G-4-301 of UAPA and 54-7-15 of PSC statute, an aggrieved party may request agency review or rehearing of our Order by filing a written request with the PSC within 30 days after issuance of the Order.<sup>3</sup> While Complainant's Request was filed within the 30-day deadline, it failed to provide proof of service to DEU, thus defeating its request for review or reconsideration.

Section 63G-4-301(1)(b)(iv) of UAPA requires that a request for agency review must "be mailed to . . . each party." DEU is the party against whom Complainant has filed its formal

complaint. However, Complainant's Request included no certificate of service or other

indication that the Request had been mailed to DEU. As such, it appears that DEU was not

served with the Request, and the 15 days in which DEU was allowed to file a response has now

elapsed.4

PSC statute allows us 20 days in which to issue our decision to grant a request for review

or hearing; otherwise the request is deemed denied.<sup>5</sup> Due to Complainant's failure to serve DEU

with the Request, we conclude Complainant has failed to timely preserve its interest in seeking

review or rehearing. We also conclude that procedural fairness dictates this result.

Accordingly, for the reasons stated above, we deny the Request and affirm our Order.
