On July 1, 2019, Dominion Energy Utah (DEU) submitted its Affiliate Transaction Report for the 12 months ending December 31, 2018 ("Report"), pursuant to the Public Service Commission's (PSC) Order Memorializing Bench Ruling Approving Settlement Stipulation in Docket No. 16-057-01. The PSC issued a notice of filing and comment period on July 2, 2019, setting comments for July 31, 2019, and reply comments for August 15, 2019. On July 26, 2019 the Division of Public Utilities (DPU) filed a request for an extension of the comment period to November 15, 2019, noting it is in the process of determining and requesting information from DEU to complete its review.
