NOTICE OF FILING AND COMMENT PERIOD

### ISSUED: September 4, 2019

### BACKGROUND

On August 30, 2019, the Public Service Commission of Utah (PSC) issued an order ("Order") denying a request for review and rehearing ("Request") filed by Alan Kruckenberg Construction, Inc. ("Complainant") against Dominion Energy Utah (DEU) in Docket No. 19-057-15. As explained in that Order: "While Complainant's Request was filed within the 30-day [statutory] deadline, it failed to provide proof of service to DEU, thus defeating its request for review or reconsideration."<sup>1</sup> Accordingly, we denied the Request.<sup>2</sup> Thereafter, on September 3, 2019, Complainant filed proof of service showing it had served DEU with its Request on August 12, 2019, which is the same day Complainant filed its Request with the PSC.

Having established DEU was served, and considering the Request raises a new issue pertaining to whether DEU failed to properly fill a trench with sand or other compactable fill,<sup>3</sup> we treat the Request as a new complaint and open this docket to consider it. Accordingly, we issue the following notice and comment period:
