Application of Dominion Energy Utah to Change the Infrastructure Rate Adjustment

On November 1, 2019, Dominion Energy Utah (DEU) filed an application to change the infrastructure rate adjustment ("Application"), effective December 1, 2019. The Application included DEU Exhibits 1.05 and 1.06 ("Original Exhibits") presenting revisions to DEU's Utah Natural Gas Tariff PSCU 500. On November 27, 2019, the PSC issued an Order approving the proposed rates on an interim basis pending results of the DPU's forthcoming audit.

On November 27, 2019, DEU filed a motion requesting the PSC replace the Original Exhibits with revised exhibits DEU Exhibits 1.05C and 1.06C in the record ("Motion").

According to DEU, Tariff Sections 5.02 and 5.04 of the Original Exhibits contain typographical errors incorrectly reflecting a change to the Base Annual Firm Demand Charge per dekatherm for the TBF and TS classes. DEU states it has discussed this matter with the Utah Division of Public Utilities (DPU) and DEU is authorized to represent the DPU supports the Motion.

Any interested party may submit comments on DEU's Motion on or before **Friday**, **December 6, 2019**. The PSC will review the Order if good cause is raised.
