Application of Dominion Energy Utah to  
Change the Infrastructure Rate Adjustment

ISSUED: December 12, 2019

On November 1, 2019, Dominion Energy Utah (DEU) filed an application to change the infrastructure rate adjustment (“Application”), effective December 1, 2019. The Application included DEU Exhibits 1.5 and 1.6 (“Original Exhibits”) presenting revisions to DEU’s Utah Natural Gas Tariff PSCU 500. On November 27, 2019, the Public Service Commission (PSC) issued an Order approving the proposed rates on an interim basis pending results of the Division of Public Utilities’ (DPU) forthcoming audit.

On November 27, 2019, DEU filed a motion requesting the PSC replace the Application’s Original Exhibits with revised exhibits DEU Exhibits 1.05C and 1.06C in the record (“Motion”). According to DEU, Tariff Sections 5.02 and 5.04 of the Original Exhibits contain typographical errors incorrectly reflecting a change to the base annual firm demand charge per dekatherm for the TBF and TS classes. DEU states it has discussed this matter with the DPU and that DEU is authorized to represent the DPU supports the Motion.

On December 2, 2019, the PSC issued a Notice of Filing and Comment Period with a comment deadline of December 6, 2019. No party filed comments and the period to do so has elapsed.

Based on DEU’s representations, the DPU’s support, and there being no opposition, we find and conclude replacement of DEU Exhibits 1.5 and 1.6 with DPU Exhibits 1.05C and 1.06C in the record is necessary, just and reasonable, and in the public interest.

Therefore, the corrected DEU Exhibits 1.05C and 1.06C are replaced in the record in this docket and are approved on an interim basis, effective December 1, 2019, pending the results of the DPU's forthcoming audit.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this written order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
