NOTICE OF DECISION ON DISPOSITIVE MOTION

On February 14, 2020, the Office of Consumer Services (OCS) filed its Motion to Dismiss Application or, in the Alternative, Motion for Summary Judgment Denying Application (“Dispositive Motion”). The same date, the Division of Public Utilities filed its Joinder in the Dispositive Motion. On March 2, 2020, Dominion Energy Utah (DEU) filed its Opposition to the Dispositive Motion. On March 13, 2020, OCS submitted a Reply in Support.

On March 16, 2020, DEU filed an unopposed Motion to Vacate Scheduling Order, Stay Discovery, and for a Scheduling Conference (“Motion to Stay”), requesting the Public Service Commission (PSC) stay the proceeding, including discovery, pending resolution of the Dispositive Motion and requesting the PSC set a date for a scheduling conference after it issues an order on the Dispositive Motion. On March 19, 2020, the PSC granted the Motion to Stay.

The PSC is working to finalize a written order on the Dispositive Motion. To avoid unnecessary delay and to allow the setting of a scheduling conference consistent with our order granting the Motion to Stay, the PSC gives notice it will deny the Dispositive Motion. A written order will issue on or before Monday, April 27, 2020, in advance of the scheduling conference we notice below.

NOTICE OF TELEPHONIC SCHEDULING CONFERENCE

The PSC gives notice its designated Presiding Officer will conduct a scheduling conference in this docket on **Friday, May 1, 2020, at 1:00 p.m.** Due to current efforts to avoid mass gatherings, we anticipate this scheduling conference will be telephonic only. In the event circumstances change such that personal attendance is appropriate and possible, the PSC will supplement this notice. If that were to occur, any party who wished to participate by telephone would, of course, be allowed to do so.
