Dominion Energy Utah (Dominion Energy or Company) respectfully moves the Utah Public Service Commission (Commission) for an extension of the deadline for filing rebuttal testimony in the above-referenced docket. This motion is brought on the following grounds.

On December 31, 2019, the Company filed an Application in this docket. On May 14, 2020, and after submission of some testimony, and the filing and resolution of a Motion to Dismiss Application or, in the Alternative, Motion for Summary Judgment Denying the Application, the Commission issued a Scheduling Order and Notice of

Hearing (Scheduling Order). The Scheduling Order provides that rebuttal testimony will be due on July 2, 2020.

The Company has been discussing settlement with the Utah Office of Consumer Services (Office) and the Utah Division of Public Utilities (Division), and anticipates engaging in settlement discussions with the Utah Association of Energy Users (UAE) and Rocky Mountain Power in the immediate future. In an effort to afford all parties the opportunity to conclude settlement discussions prior to submitting additional testimony, the Company requests that the Commission extend the deadline for filing rebuttal testimony until July 8, 2020. At this time, the Company does not believe that any other dates in the Scheduling Order need to be modified.

Counsel for the Company has communicated with counsel for the Office, the Division, UAE and Rocky Mountain Power and all counsel have indicated that their respective clients either support or do not oppose this motion.

Based upon the foregoing, the Company respectfully requests that the Commission amend the Scheduling Order to extend the deadline for filing rebuttal testimony from July 2, 2020 until July 8, 2020.
