ORDER GRANTING MOTION
TO AMEND APPLICATION

ISSUED: July 7, 2020

Dominion Energy Utah (DEU) initiated this docket on December 31, 2019, filing an application for the Public Service Commission's (PSC) approval of two programs for funding pursuant to Utah Code Ann. § 54-4-13.1 and Utah Code Ann. § 54-20-105. The parties and the PSC have referred to the two proposed programs as "IIAC" and "CHP," respectively.

On June 12, 2020, DEU filed a Motion for Leave to Amend the Application ("Motion"), seeking to remove its request for approval of the CHP project. On June 15, 2020, the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) each filed direct testimony in this docket. The testimony from the DPU and the OCS acknowledges the Motion and either expressly supports the Motion or does not appear to oppose it. No party filed notice of its opposition to the Motion.

Good cause appearing and hearing no opposition, the Motion is granted.
