Questar Gas Company dba Dominion Energy Utah (DEU or Company) respectfully submits these Reply Comments pursuant to the Utah Public Service Commission's (Commission) Notice of Filing and Comment Period issued on June 13, 2022 in the above-referenced docket (Notice).

On June 7, 2022, DEU filed its Annual Report related to the Sustainable Transportation and Energy Plan for the program year beginning on March 1, 2021 and ending February 28, 2022 (Report). On June 13, 2022, the Commission issued the Notice and directed any interested person to submit comments on or before July 7, 2022, and any Reply Comments on or before July 22, 2022. On July 7, 2022, the Utah Division of Public Utilities (Division) submitted an Action

Request Response (Response). The Company submits these Reply Comments in response to the Division's Response.

The Division's Response summarized the Intermountain Industrial Assessment Center's (IIAC) first year's program performance and recognized that the IIAC completed the required 20 energy efficiency assessments and 40 clean air assessments for qualifying Utah businesses as per the terms of the Settlement Stipulation in this docket, dated July 16, 2020.

The Division also noted that Company, the Division, and the Utah Office of Consumer Services (Office) collaborate on the form of reporting and that, as a result, the form of the reports evolve over time, or are "a work in progress". The Company agrees and appreciates the input of both the Division and the Office in developing reports that provide needed and useful information. The Company commits to continue to work with the Division and Office in the future to refine and improve reporting to ensure that the Commission and interested parties have access to accurate, complete, and useful information.


The Division recommended that in future annual reports, the Company (1) provide all information and data to support the tables and illustrations in the report in Excel format with intact formulae (where applicable), and (2) provide an exhibit in Excel format with intact formulae illustrating the revenues for the program generated by tariff surcharges, expenses, carrying charges, and the account balance. The Company agrees with these recommendations and will incorporate them into future annual reports.

The Division concluded that DEU and the IIAC followed the Commission's Orders at a high-level for the quarterly and annual reports and recommended that the Commission

acknowledge the Annual Report. The Company appreciates the Division's analysis and agrees with this recommendation.
