ORDER VACATING HEARING

On January 29, 2019, the Public Service Commission of Utah (PSC) issued a Scheduling Order and Notice of Hearing (Scheduling Order) in this docket. The Scheduling Order set a February 15, 2019 hearing date. On February 14, 2019, Dominion Energy Utah (DEU) filed a motion requesting the PSC vacate the February 15, 2019 hearing and schedule a scheduling conference (Motion). DEU's Motion represents that it has communicated with the representatives of the Division of Public Utilities and the Office of Consumer Services, and they both support the Motion. Based on the reasons set forth in the Motion, and for good cause appearing, the PSC grants the Motion. Accordingly, the February 15, 2019 hearing is vacated.
