Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully moves the Utah Public Service Commission (Commission) issue a Scheduling Order providing Dominion Energy the opportunity to submit reply comments in the above referenced matters.


On December 2, 2020, Dominion Energy submitted its Report on Energy Efficiency Expenditures and Dekatherm Savings to Date. The Commission promptly issued an Action Request directing the Utah Division of Public Utilities (Division) to review the submission for compliance and to make recommendations by December 31, 2020. On December 30, 2020, the Division issued an Action Request Response that included a number of recommendations, including a recommendation to reduce the

allowed spending for the ThermWise Appliance Program, the ThermWise Home Energy Plan, and Market Transformation.

The Company respectfully request the opportunity to address matters raised in the Division's Action Request Response. Accordingly, Dominion Energy respectfully requests that the Commission issue a Scheduling Order permitting the Company the opportunity to submit reply comments by January 15, 2021.
