On February 25, 2020, the Public Service Commission (PSC) issued a Report and Order (“February Order”) in Docket No. 19-057-02.¹ The Order states:

We also find that a separate proceeding following our final order on the rates in this case is an appropriate and reasonable means to evaluate the TS class composition and other cost allocation issues associated with rate classes. It will provide adequate time for study before [Dominion Energy Utah] files its next [general rate case]. Accordingly, we will establish an investigatory proceeding in a new docket shortly after the reconsideration period for this order concludes.

In addition, the PSC’s April 14, 2020 Order Denying Petitions for Agency Review and Rehearing of the PSC’s February Order clarified that issues pertaining to TS customer open enrollment and the TS customer administrative charge raised by the American Natural Gas Council will be included in the investigatory proceeding identified in the February Order.²

The PSC’s designated presiding officer will conduct a telephonic scheduling conference in this docket on **Wednesday, May 27, 2020, at 1:00 p.m.** Due to current efforts to avoid mass gatherings, this scheduling conference will be telephonic only.
