Dominion Energy Utah (Dominion Energy or Company) respectfully moves the Utah Public Service Commission (Commission) to amend the Scheduling Order and Notice of Status Conference (Scheduling Order) in the above-referenced docket. This motion is brought on the grounds set forth below.

On May 19, 2020, the Commission opened this docket and on May 28, 2020 issued a Preliminary Scheduling Order setting a Scoping Meeting for June 8, 2020. The Preliminary Scheduling Order directed the Utah Division of Public Utilities (Division) to report on the outcome of that meeting.

On June 8, 2020, interested parties met and agreed upon a schedule for proceedings. Among other things, the interested parties agreed that the stakeholders would meet on July 8, August 12, and September 9, 2020 to discuss various matters related to this docket. The interested parties agreed that each meeting would be held from 10:00 a.m. to 12:00 p.m.

On June 22, 2020, the Division issued its report on the scoping meeting in which it indicated that all interested parties had agreed to hold informal meetings on July 8, August 12, and September 9, 2020. Division's Memorandum at pp. 2-3. The Division's Memorandum did not specify a time for each meeting.

On June 25, 2020, the Commission issued the Scheduling Order which indicated that the July 8, August 12, and September 9, 2020 informal meetings would be held from 1:00 p.m. to 4:00 p.m.

Because the interested parties have conferred and agreed to meet from 10:00 a.m. to 12:00 p.m. on each specified day, Dominion Energy respectfully requests that the Commission amend its Scheduling Order to reflect that the parties will meet from 10:00 a.m. to 12:00 p.m. on each of the specified days
