Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-1-108, the Federal Executive Agencies (FEA), through its undersigned counsel, hereby files its Petition For Leave To Intervene in the above-captioned docket. In doing so, FEA states the following:

1. The FEA represents numerous federal customers within the area serviced by Dominion Energy Utah (“the Company”). These entities include, but are not limited to, military installations, post offices, and federal buildings. For example, Hill Air Force Base (“Hill AFB”) represents a significant transportation service customer to the Company. The outcome of this case could affect Hill AFB's transportation service rates, particularly how these rates are determined in the next rate case filed by the Company.

2. The FEA has a substantial legal interest in this case and will be affected by any changes to the transportation class resulting from the Commission's decision in this case.

No other party is likely to adequately represent FEA's interests in this proceeding.

3. The interests of justice and the orderly and prompt conduct of the above proceeding will not be impaired by FEA's intervention and FEA will comply with the scheduling order issued in the docket.
