### ISSUED: October 19, 2023

On August 7, 2023, the Division of Public Utilities (DPU) responded to the Public Service Commission's (PSC) action request seeking DPU's anticipated schedule to complete its recommendation for setting final rates in the infrastructure tracker dockets referenced above (DPU's Final Rates Recommendation").<sup>1</sup> On August 10, 2023, the PSC issued a Notice of Filing and Comment Period seeking comments on DPU's Final Rates Recommendation.

A review of the PSC's historical processes in infrastructure tracker dockets revealed that the PSC typically approves final rates in infrastructure tracker dockets in Dominion Energy Utah's General Rate Cases ("GRC"), as was the case for the referenced dockets (Docket Nos. 20-057-21 and 21-057-26). Final rates for these dockets were set and approved as part of DEU's GRC in Docket No. 22-057-03, hence there was no need for the PSC's action request.

The PSC appreciates DPU's work and response to the unnecessary action request. To avoid confusion, we affirm that we expect final rates for all infrastructure tracker costs in the future will continue to be set in DEU GRC dockets. The PSC will no
