Pursuant to Utah Code Ann. §54-4-1 *et seq.*, and Utah Administrative Code §§ R746-1-101 *et seq.* and R746-405-1 (2019) *et seq.*, Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully submits this Notice of Intent to File Replacement Infrastructure 2021 Annual Plan and Budget and Motion for Extension of Time.


Section 2.07 of the Company's Utah Natural Gas Tariff No. 500 (Tariff) provides that "[t]he Company will file its next year's annual plan and budget describing the estimated costs and schedule for the Replacement Infrastructure with the Commission no later than November 15 of each year." Tariff at §2.07. The Company has been diligently working to complete the 2021 replacement infrastructure annual plan and budget. However, a key employee responsible for preparing the budget has unexpectedly been out

of the office on bereavement leave, and as a result, the Company has not yet completed the budget. The Company anticipates this employee will return to work soon and that it can complete the 2021 annual plan and budget by November 30, 2020. The Company therefore respectfully requests an extension of the deadline for submitting the 2021 annual plan and budget until November 30, 2020.

Based upon the foregoing, the Company provides notice of its intent to file a 2021 Replacement Infrastructure Annual Plan and Budget and moves the Commission for an Order extending the deadline for doing so until November 30, 2020.
