ORDER GRANTING MOTION FOR  
EXTENSION OF TIME

ISSUED: November 18, 2020

On November 16, 2020, Dominion Energy Utah (DEU) filed a Motion for Extension of Time ("Motion") with the Public Service Commission (PSC) to file its 2021 Replacement Infrastructure Annual Plan and Budget ("2021 Plan") until November 30, 2020. Section 2.07 of DEU's Utah Natural Gas Tariff No. 500 provides that DEU "will file its next year's annual plan and budget describing the estimated costs and schedule for the Replacement Infrastructure with the [PSC] no later than November 15 of each year." DEU states a key employee responsible for preparing the 2021 Plan has unexpectedly been out of the office and that this employee should be returning to work soon to complete the 2021 Plan in order to file it with the PSC by November 30, 2020.

Based on our review of the Motion, we find the extension of time requested by DEU to file its 2021 Plan is reasonable. Accordingly, we grant DEU's Motion. DEU shall file its 2021 Plan by **Monday, November 30, 2020**.
