On January 7, 2021, Dominion Energy Utah (DEU) filed with the Public Service Commission (PSC) a Notice of Intent to File Integrated Resource Plan and Request for Scheduling Order and Notice of Technical Conferences ("Notice"). The Notice states DEU intends to file its integrated resource plan for the plan year of June 1, 2021 through May 31, 2022 ("2021 IRP") in early June 2021.
