On July 8, 2021, the Public Service Commission (PSC) issued a Scheduling Order in this docket. On September 9, 2021, Dominion Energy Utah (DEU) filed a Motion to Amend the Scheduling Order ("Motion"). In the Motion, DEU moves for an additional technical conference to the schedule and to modify the deadline for comments. DEU further states it has communicated with representatives of the Division of Public Utilities and the Office of Consumer Services and is authorized to represent that neither opposes the Motion.
