Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) hereby requests that the Utah Public Service Commission (Commission) vacate the April 27, 2021 reply deadline in this docket. On March 15, 2021, the Commission issued a Notice of Filing and Comment Period requiring Dominion Energy to file a response on or before April 12, 2021, and permitting Symphony Homes to submit reply comments on or before April 27, 2021. The Commission subsequently granted a Motion allowing Dominion Energy to submit its response on or before April 19, 2021. On April 19, 2021, Dominion Energy filed its response.

The Company and Symphony Homes (together the Parties) have continued to engage in settlement discussions and believe that they are likely to reach a settlement on the issues raised in the Formal Complaint. In order to allow sufficient time for settlement

negotiations to transpire, Dominion Energy requests that the Commission vacate the April 27th reply deadline. If it is determined that efforts to negotiate a settlement in this matter are not advancing, the Parties will notify the Commission and Symphony Homes will file a response within ten (10) days of that date. Counsel for Dominion Energy has spoken with counsel for Symphony Homes and Dominion Energy is authorized to represent that Symphony Homes supports this motion.

Therefore, Dominion Energy requests that the Commission vacate the current deadline for Symphony Homes to reply to Dominion Energy's Response as described above.
