On April 21, 2021, Dominion Energy Utah (DEU) filed a Motion to Vacate Reply Deadline (“Motion”). DEU requests the Public Service Commission (PSC) vacate the April 27, 2021 reply deadline in this docket. DEU states it has been in settlement discussions with Symphony Homes and believes the parties are likely to reach a settlement on the issues raised in the formal complaint.

DEU states it has communicated with Symphony Homes and is authorized to represent that Symphony Homes supports the Motion. Good cause appearing, and based on DEU’s representation that Symphony Homes supports the Motion, the Motion is granted. The PSC vacates the April 27, 2021 reply deadline.
