Dear Chris:

Attached please find copies of the Energy Efficiency Report for the year ending December 31, 2021. This report was designed and prepared based on recommendations from the DPU and Dominion Energy for the purpose of providing information on Dominion Energy's energy-efficiency programs and to assist the Division in monitoring and reporting the status of these programs. The report provides quarterly and year-to-date information on participants, costs, and natural gas savings for the Company's energy-efficiency programs.

Total spending for the 2021 program year was approximately \$25.0 million or 92.5% of the \$27.1 million Commission-approved ThermWise® budget. For the Appliance, Builder, Business, Weatherization, and Energy Comparison Report Programs, actual spending was consistent the approved respective program budgets. Spending for these programs reached approximately 94.8% percent of their respective approved program budgets. The Market Transformation, Low Income, and Home Energy Plan Programs had expenditures that were lower than expected (approximately 76.3% of budget), which was primarily due to the continued impact of the COVID-19 pandemic. The majority of 2021 program year resulted in the cancellation of community initiatives, trade and consumers shows, and community campaigns. However, the Company did participate in those initiatives that were reopened later in 2021. The Company anticipates that the expenditures for ThermWise® programs and Market Transformation initiatives will return to a more historical level once the impacts from COVID-19 have subsided.

In January 2022, the Company reported that expenditures for the Weatherization Program surpassed 90% of 2021 Commission approved budget. In this report, the Company provided forecasted year-end expenditures for the Weatherization Program of \$7.7 million or 99% of the \$7.8 million program budget. Actual year-end Weatherization Program expenditures was approximately \$7.5 million, which totaled 96.5% of the 2021 budget.

In total, rebate dollars accounted for approximately 81% of total ThermWise® spending in 2021 (forecasted ~81% in 2021 budget) and resulted in annual natural gas savings of 931,953 decatherms.
