Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully moves to the Utah Public Service Commission (Commission) for an order approving the implementation of Step 2 rates pursuant to the Commission’s Report and Order (Order) in this Docket dated December 23, 2022 and the Errata Order dated January 3, 2023.

In its Order, the Commission indicated that “[a] portion of the increase for the TSL customers will be implemented on the effective date of the order. A second portion will be implemented on July 1, 2023, and the remaining portion on July 1, 2024.” Order at pp. 49. Accordingly, the Company respectfully submits this Motion, and has attached legislative and final updates to its Utah Natural Gas Tariff No. 600 (Tariff). Legislative

Tariff sheets are attached as DEU Exhibit 1.01 and final Tariff sheets are attached as DEU Exhibit 1.02.

As shown in DEU Exhibits 1.01 and 1.02, the Company submits Step 2 changes to the base DNG rates of the TBF, TSS, TSM, and TSL rate classes according to the rates established on table 9 of the Errata Order at pp. 3. Based on the foregoing, Dominion Energy respectfully requests that the Commission acknowledge the Step 2 rates as shown in DEU Exhibit 1.02 as final rates, effective July 1, 2023.
