#### SETTLEMENT STIPULATION

GAIL MENDENHALL and Questar Gas Company dba DOMINION ENERGY UTAH (together the Parties) have agreed to the following terms as a full and final resolution of the Formal Complaint filed on May 7, 2022, PSCU Docket No. 22-057-07:

- (a) Dominion Energy Utah agrees to credit Ms. Mendenhall's account in the amount of \$212.15 to reflect an offset of the balance resulting from a cross meter at the Service Address of 4876 West Black Twig Drive, South Jordan, Utah 84009; and
- (b) Dominion Energy Utah will provide Ms. Mendenhall with a free Home Energy Audit to identify potential cost and energy saving options.

In exchange for the consideration described above, Ms. Mendenhall has agreed to dismiss the Formal Complaint filed with the Public Service Commission of Utah, PSCU Docket No. 22-057.07.

The Parties represent and agree that this Settlement Stipulation is entered into in order to resolve disputed claims. The Parties agree that no part of this Settlement Stipulation, or the formulae or methods used in developing the same, or a Commission order approving the same, shall in any manner be argued or considered an admission of wrongdoing, or as precedential in any future case. This Settlement Stipulation does not resolve, does not provide any inferences regarding, and the Parties are free to take any position with respect to, any issues not specifically identified and settled herein. All negotiations related to this Settlement Stipulation are confidential and subject to the applicable rules of evidence, including Utah R. Evid. 408, and no Party shall be bound by any position asserted in negotiations not specifically identified and settled herein. Neither the execution of this Settlement Stipulation nor an order adopting it shall be deemed to constitute an admission or acknowledgment by any Party of the validity or invalidity of any claim or defense; nor shall they be construed to constitute the basis of an estoppel or waiver by any Party; nor shall they be introduced or used as evidence for any other purpose in a future proceeding by any Party except in a proceeding to enforce this Settlement Stipulation.
