## APPLICATION

Pursuant to Utah Code Ann. §54-4-1 *et seq.*, Utah Administrative Code § R746-405-2 (2019), and the Order Approving Settlement Stipulation in Docket No. 21-057-24 (Order), Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully submits this Application to the Utah Public Service Commission (Commission) and requests approval to modify its Utah Natural Gas Tariff No. 500 (Tariff) to include provisions related to meter protection.

On October 1, 2021, Dominion Energy and the Utah Division of Public Utilities (Division) submitted a Motion to Approve Joint Stipulation and Request for Scheduling Conference in Docket No. 21-057-24, with an attached Settlement Stipulation. The Settlement Stipulation described an incident that occurred at a condominium complex in Alta, Utah on February 16, 2019. The Division and Company entered into the Settlement Stipulation that required, among other things, that Dominion Energy take certain steps to

assess meters on its system and place snow protection on those that were likely to benefit

from that protection.

On December 14, 2021, the Commission held a hearing on the matter. During the

hearing, Dominion Energy represented that it intended to update its Tariff to reflect the

plans related to meter protection described in the Settlement Stipulation.

On January 20, 2021, the Commission issued the Order and said, "We direct DEU

to file its updated tariffs consistent with the Settlement and this Order within 60 days from

the issuance of our Order." Order at p. 5.

The Company therefore proposes Tariff changes reflective of the provisions of the

Settlement Stipulation and in compliance with the Order. DEU Exhibit A contains the

proposed Tariff changes in legislative format, and DEU Exhibit B contains the proposed

Tariff pages in final format.

WHEREFORE, Dominion Energy respectfully requests that the Commission enter

an Order authorizing Dominion Energy to implement the Tariff changes reflected in DEU

Exhibits A and B, effective April 1, 2022.
