MOTION TO UPDATE

Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully moves the Utah Public Service Commission (Commission) to accept the attached updated DEU Exhibits AU and BU, and replace DEU Exhibits A and B to the Application in this docket with the attached exhibits. This Motion is brought on the grounds set forth below.

On February 18, 2022, Dominion Energy filed the Application in this matter with accompanying DEU Exhibits A and B. On that same day, the Company provided a courtesy notification of the filing to the Utah Homebuilder's Association (the HBA). The HBA contacted Dominion Energy with some suggested changes and clarifications to the proposed exhibits. Dominion Energy worked with the HBA and spoke with representatives of the Utah Division of Public Utilities (Division) about the matter. As a result of these discussions, Dominion Energy has made some modifications to the changes

it originally proposed to its Utah Natural Gas Tariff No. 500 (Tariff). Those changes are included in the attached DEU Exhibits AU and BU. The Company respectfully requests that the Commission accept the updated exhibits and replace the originally filed exhibits with those attached hereto.

The Company does not believe that permitting the update of the referenced exhibits warrants any change in the schedule for this matter. The Company has spoken to representatives of the Division, the HBA, and the Utah Office of Consumer Services and is authorized to represent that none of those entities oppose this Motion.
