Questar Gas Company dba Dominion Energy Utah (Dominion Energy Utah or the Company) respectfully submits this Application for a change to the Infrastructure Rate Adjustment Tracker program as described in §2.07 of the Company's Utah Natural Gas Tariff No. 500 (Tariff). This requested change aligns the Tariff with the Utah Public Service Commission's Report and Order dated February 25, 2020 in Docket No. 19-057-02 (Order), and allows the Company to provide updated master lists of footages its High Pressure (HP) and Intermediate High Pressure (IHP) pipelines (Master Lists) in June of each year rather than in April.

In support of this Application, Dominion Energy Utah states:

1. Dominion Energy Utah's Operations. Dominion Energy Utah, a Utah corporation, is a public utility engaged in the distribution of natural gas primarily to customers in the states of Utah and Wyoming. Its Utah public utility activities are regulated by the Commission, and the

Company's rates, charges, and general conditions for natural gas service in Utah are set forth in the Tariff. Copies of the Company's Articles of Incorporation are on file with the Commission. In addition, the Company serves customers in the Franklin County, Idaho area. Under the terms of an agreement between the Commission and the Idaho Public Utilities Commission, the rates for these Idaho customers are determined by the Utah Commission.

2. Background: In its Order the Commission authorized Dominion Energy Utah to file updated Master Lists in June of each year, an extension from the previously existing deadline of April 30th of each year. Specifically, on page 11 of the Order, the Commission states:

Additionally, we find and conclude resetting the required ITP reporting date for DEU's master lists from April 30 to June 30 will not impact ratepayers and will improve the ability of regulators to evaluate the program; therefore, we approve DEU's proposal.

Consistent with the Order, the Company filed updates of the Master Lists in June of 2020, 2021, and 2022. It has since come to the Company's attention that due to an oversight the first paragraph of Section 2.07 of the Tariff has not yet been updated to reflect the date change in the Order, and this filing remedies the discrepancy.


3. Tariff Change. The outdated reference to April is found in the first paragraph of Section 2.07 of the Tariff. DEU Exhibit 1.1 provides proposed tariff sheets reflecting the change from April to June. In addition, Final tariff sheets are provided as DEU Exhibit 1.2. Approval of this Application will not result in any material impact to the Infrastructure Rate Adjustment Tracker program.

WHEREFORE, Dominion Energy Utah respectfully requests the Commission enter an order approving the proposed update of the Tariff as more fully described in this Application and consistent with the Order in Docket No. 19-057-02.
