ISSUED: January 12, 2023

On January 10, 2023, Dominion Energy Utah (DEU) filed with the Public Service Commission (PSC) a Notice of Intent to File Integrated Resource Plan and Request for Scheduling Order and Notice of Technical Conferences (“Notice”). The Notice states DEU intends to file its integrated resource plan for the plan year of June 1, 2023 through May 31, 2024 (“2023 IRP”) in early June 2023. To the extent the parties cannot come to an agreement, the parties should submit their dispute to the PSC at the earliest practicable date in advance of the conference.
