Pursuant to the Order Approving Stipulation issued on November 17, 2015 in Docket No. 15-057-10 (Settlement Stipulation), Questar Gas Company dba Dominion Energy Utah (Dominion Energy) respectfully submits this report of the five-year forward curve. The curve is included as DEU Exhibit 1. This curve was calculated using the same method as described in paragraph 14 of the Settlement Stipulation. The spreadsheet detailing the calculations underlying the five-year forward curve is included as DEU Exhibit 2. For informational purposes, Dominion Energy has also included DEU Exhibit 3, which shows that during the 2022-2023 IRP year, 47.6% of the forecast demand for Dominion Energy customers was supplied by Wexpro production.
