Pursuant to the Notice of Filing and Comment Period issued on January 8, 2026 in the above-referenced dockets, Questar Gas Company dba Enbridge Gas Utah (“Enbridge Gas” or “Company”) respectfully submits these Reply Comments in response to the Utah Division of Public Utilities (“Division”) Audit of Dominion Energy Utah’s 191 Account for the Calendar Year 2024, filed on December 30, 2025.

On February 1, 2023, in Docket No. 23-057-03; December 28, 2023, in Docket No. 23-057-25; June 3, 2024, in Docket No. 24-057-09; and October 1, 2024, in Docket No. 24-057-16 the Company filed Applications with the Public Service Commission of Utah (“Commission”) requesting approval of interim rates to adjust rates and charges applicable to its Utah natural gas service, reflecting annualized gas costs.

The Company has reviewed the Division’s Audit Report and has no opposition to the findings or recommendations contained therein. Enbridge Gas Utah appreciates the Division’s

diligent and thorough review of the 191 Account and acknowledges the Division's efforts to ensure that the rates and associated calculations are just, reasonable, and in the public interest.
