ISSUED: November 20, 2023

On November 6, 2023, the Public Service Commission (PSC) issued a Request for Response (“Request”) in this docket stating, “it appears that [Nicole Rae McLaughlan] Lovato [(“Complainant”)] and [Dominion Energy Utah (DEU)] may have reached an agreement concerning the Complaint or that it has otherwise been resolved.” The Request directed the Complainant and DEU to advise the PSC whether the Complaint has been resolved. On November 14, 2023, the Complainant and DEU each filed their responses indicating the Complaint has not been resolved.

Accordingly, the PSC will conduct a virtual hearing in this matter on **Friday, December 15, 2023, beginning at 10:00 a.m.** The hearing will be held via Webex at the following link: <https://utah-psc.webex.com/utah-psc/j.php?MTID=mcaece1e3cde774ade4690fd2ebd457d8>

All parties must have their witnesses in attendance and prepared to testify. The PSC requests that attorneys and witnesses make themselves available by both video and audio during the portions of the hearing in which they will be actively participating.
