ORDER GRANTING IN PART MOTION TO AMEND SCHEDULING ORDER, NOTICE OF TECHNICAL CONFERENCE, NOTICE OF PUBLIC WITNESS HEARING, AND NOTICE OF HEARING

ISSUED: February 29, 2024

On November 7, 2023, the Public Service Commission (PSC) issued a Scheduling Order, Notice of Technical Conference, Notice of Public Witness Hearing, and Notice of Hearing in this docket (the "Scheduling Order"). The Scheduling Order set certain dates that included, as relevant here, the deadlines for filing rebuttal and surrebuttal testimony, and the dates for the public witness and evidentiary hearings.

On February 27, 2024, Dominion Energy Utah (DEU) filed a Motion to amend the Scheduling Order ("Motion"). The Motion represents that the parties in this docket – DEU, Enbridge Quail Holdings, LLC, the Division of Public Utilities, the Office of Consumer Services, the Utah Association of Energy Users, and the Idaho Public Utilities Commission ("Parties") – "have engaged in settlement discussions and believe they are likely to reach a settlement in this" docket. The Motion requests the PSC "to amend the Scheduling Order such that the March 4th [rebuttal testimony filing deadline] would be vacated, and rebuttal testimony would be due on March 29, 2024. All other dates, deadlines, and provisions of the Scheduling Order would remain the same." The Motion further represents that DEU has "discussed this Motion with all of

the Parties and ... is authorized to represent that all Parties support this Motion." The Motion does not address the Scheduling Order's surrebuttal deadline of March 29, 2024.

Good cause appearing, and based on DEU's representations that the Parties support the Motion, the Motion is granted in part as follows:

- 1. The current deadline of March 4, 2024, for filing rebuttal testimony is vacated;
- 2. The new deadline for filing rebuttal testimony is March 29, 2024;
- 3. The new deadline for filing surrebuttal testimony is April 8, 2024;
- 4. All other dates, times, and locations in the Scheduling Order (i.e., the evidentiary hearing and public witness hearing) remain unchanged.

NOTICE OF PUBLIC WITNESS HEARING

The PSC will conduct a Public Witness Hearing in this docket on Thursday, April 11, 2024, beginning at 5:00 p.m., Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The Public Witness Hearing will continue until all present individuals have had a reasonable opportunity to address the PSC. Individuals planning to address the PSC must be present by 5:30 p.m.

The PSC may limit remarks that are unduly repetitious at the Public Witness

Hearing. The PSC desires to provide an opportunity for all individuals who desire to

speak to do so. As such, the PSC may limit the length of individuals' remarks. Any

individual wishing to present a statement of position to the PSC that is unable to do so

during the Public Witness Hearing may file a written statement of position with the

PSC at its office, Fourth Floor, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah 84111 in person, by mail, by email to psc@utah.gov, or by facsimile to 801–530–6796. Please indicate that the statement pertains to Docket No. 23–057–16.
