2 PRESIDING OFFICER: Okay. Good evening,
3 everyone. My name is John Delaney, and I'm the
4 Commission's designated presiding officer for this
5 hearing. With me are Commissioners David Clark and John
6 Harvey.

7 Today is April 11th, 2024, and it's
8 approximately 5:00 p.m. This is the date and time that
9 is scheduled for the members of the public to comment on
10 the Joint Application of Questar Gas Company dba
11 Dominion Energy Utah and Enbridge Quail Holdings, LLC,
12 for Approval of the Proposed Sale of Fall West Holdco,
13 LLC, to Enbridge Quail Holdings, LLC. That's Docket
14 23-057-16.

15 So at this point it doesn't appear that we
16 have anyone present. So --

17 COMMISSIONER HARVEY: Anyone from the public.

18 PRESIDING OFFICER: What's that? I'm sorry.

19 COMMISSIONER CLARK: Anyone that counts.

20 PRESIDING OFFICER: Critical clarification.

21 It should be noted. Nobody from the public has yet
22 shown up for the public witness hearing.

23 So our notice indicated that we would give
24 anybody present by 5:30 a reasonable time to comment.
25 So why don't we give everybody who may or may not want

1 to comment a little bit more time. So I think what we
2 should do is go into recess now until the sooner of a
3 member of the public appears or right around 5:30. So
4 let's reconvene back here at 5:30 if we haven't heard
5 from anybody else showing up, which our staff will let
6 us know, and we'll get everybody together. Okay?

7 MR. BURNETT: Thank you.

8 PRESIDING OFFICER: Okay. We're in recess.
9 Thank you.

10 (Recess taken from 5:01 to 5:31.)

11 PRESIDING OFFICER: So let's go back on, and
12 why don't we do appearances because I didn't do
13 appearances last time.

14 So let's start with the Division.

15 MS. SCHMID: Good afternoon. Patricia E.
16 Schmid, Assistant Attorney General, and Patrick Grecu,
17 also an assistant attorney general, for the Division of
18 Public Utilities.

19 PRESIDING OFFICER: Thank you.

20 MR. MOORE: Robert Moore of the AG's Office,
21 attorney for the Office of Consumer Services.

22 PRESIDING OFFICER: Thank you very much.

23 And for Questar Gas?

24 MS. CLARK: Jenniffer Clark, counsel for
25 Questar Gas.

1 PRESIDING OFFICER: Thank you.

2 And for Quail Enbridge?

3 MR. BURNETT: Brian Burnett, counsel for
4 Enbridge Quail Holdings, LLC.

5 PRESIDING OFFICER: Thank you. Okay. It's
6 approximately 5:35 now, and according to my
7 understanding and everybody else's confirmation of that,
8 nobody from the public has arrived to provide some
9 testimony.

10 Okay. Then thank you for coming tonight, and
11 we will be adjourned.


