Review of the Carrying Charges Applied to Various Dominion Energy Utah Account Balances DOCKET NO. 23-057-T02

ORDER

ISSUED: March 24, 2023

BACKGROUND

On February 23, 2023, Dominion Energy Utah (DEU) filed an application ("Application") with the Public Service Commission (PSC) to revise its Natural Gas Tariff No. 600 ("Tariff") to update the annual carrying charge ("Carrying Charge") set forth in Section 8.07, Calculation of Carrying Charge. DEU seeks to increase the Carrying Charge from 3.05 percent to 4.58 percent, effective April 1, 2023.¹

On February 24, 2023, the PSC issued a Notice of Filing and Comment Period.

On March 8, 2023, the Division of Public Utilities (DPU) filed comments recommending the PSC approve the Application. No other party filed comments.

DPU comments that DEU's calculations of the proposed Carrying Charge are correct and consistent with the calculation methodology approved by the PSC in its February 23, 2017 Order in Docket No. 17-057-T01 ("Order").² Based on its analysis and review, DPU recommends the PSC approve DEU's revised Tariff, which increases the Carrying Charge to 4.58 percent, effective April 1, 2023.

DISCUSSION, FINDINGS, AND CONCLUSIONS

The PSC finds that, consistent with DPU's comments, DEU correctly calculated the Carrying Charge in accordance with the PSC-approved methodology, and DEU timely filed its Application to update the Carrying Charge before the March 1 deadline set forth in the Order.

Based on those findings, the PSC's review of the Application and Tariff, DPU's comments and recommendation, and in the absence of any opposition to the Application, the PSC concludes the revised Tariff is consistent with the Order.

ORDER

The revised Section 8.07 of DEU's Tariff is approved as filed, effective April 1, 2023.

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this written order by filing a request for review or rehearing with the PSC within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC fails to grant a request for review or rehearing within 30 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
