Based on a review of the (1) Verified Request for Review and Consideration of an Order to Proceed, including the testimony and exhibits thereto, filed by Enbridge Gas Utah (EGU) on June 23, 2025 ("Request"); (2) Action Request Response of the Division of Public Utilities (DPU) filed July 9, 2025; and (3) Settlement Stipulation filed January 9, 2025, relating to EGU's Verified Application for Approval of a Rural Natural Gas Infrastructure Development Project to Extend Service to Portage, Utah, filed September 20, 2024 ("Underlying Application"), it is unclear whether EGU and DPU intend that all terms of the Settlement Stipulation shall remain in full force and effect if the Request is granted.

Accordingly, please submit to the PSC by **Friday, August 8, 2025**, a verified statement either:

- (1) Confirming that all terms of the Settlement Stipulation shall remain in full force and effect if the Request is granted; or
- (2) Disputing that all terms of the Settlement Stipulation shall remain in full force and effect if the Request is granted and provide an explanation as to the basis for that dispute.
