Pursuant to the Utah Public Service Commission’s (Commission) Report and Order issued on February 21, 2025 in the above-referenced docket, Questar Gas Company dba Enbridge Gas Utah (Company, EGU, or Enbridge) respectfully submits three (3) permits and a copy of the franchise agreement related to the Company’s expansion into the town of Portage, Utah.

On August 23, 2024, Enbridge filed a notice with the Commission that it intended to file a voluntary request for Commission approval to extend its high pressure and intermediate-high pressure natural gas distribution system to the town of Portage, Utah. On January 9, 2025, the Company jointly submitted a Settlement Stipulation with the Utah Division of Public Utilities (Settlement). On February 21, 2025, the Commission issued an Order approving the Settlement. The Order provided, among other things, that the Commission recognized that the signatories of the settlement agreed “EGU will file copies of the permits and franchise agreement with Portage,

and “other similar items ... when they have been gathered in their entirety, are finalized, and executed” Order at p. 3.

Since that time, the Company obtained certain permits related to constructing that expansion and the franchise agreement with Portage. EGU Exhibit 1 is a table with descriptions of each permit collected. EGU Exhibits 2 through 4 are copies of the permits and EGU Exhibit 5 is a copy of the franchise agreement.
