Questar Gas Company dba Enbridge Gas Utah (Enbridge Gas or Company) respectfully submits this Application (Application) to Modify its Tariff to Reflect its Name Change pursuant to Utah Admin. Code R746-405-1. Enbridge Gas has also attached the proposed Utah Natural Gas Tariff No. 700 (Tariff) for the Utah Public Service Commission’s (Commission) review and approval.

In support of this Application, Enbridge Gas states as follows:

On September 5, 2023, Dominion Energy, Inc. announced its intention to sell Questar Gas Company dba Dominion Energy Utah’s parent company, Fall West HoldCo LLC to Enbridge Quail Holdings LLC. On October 20, 2023, Questar Gas Company dba Dominion Energy Utah filed a Joint Application with Enbridge Quail Holdings LLC for Commission approval of the sale of Dominion Energy Utah. On May 16, 2024, after robust proceedings and the submission of a Settlement Stipulation signed by all parties, the Commission approved the sale. *See* Order Approving Settlement Stipulation issued May 16, 2024, Docket No. 23-057-16 (Order). As a

result of those proceedings and the Order, Questar Gas Company now does business as Enbridge Gas Utah.

Accordingly, Enbridge Gas respectfully submits the updated Tariff, legislative and clean copies of which are attached hereto as EG Exhibit 1.0 and 2.0, respectively, for Commission review and approval. The Tariff has been modified only to reflect Enbridge Gas's name change. Enbridge Gas represents that the attached Tariff sheets do not constitute a violation of state law or Commission rule.

WHEREFORE, Enbridge Gas respectfully requests the Commission enter an order approving the attached Utah Natural Gas Tariff No. 700, reflecting Enbridge Gas's recent name change effective July 1, 2024.
