Pursuant to the Order Approving Stipulation issued on November 17, 2015 in Docket No. 15-057-10 (Settlement Stipulation), Questar Gas Company dba Enbridge Gas Utah (Enbridge Gas) respectfully submits this report of the five-year forward curve. The curve is included as EGU Exhibit 1. This curve was calculated using the same method as described in paragraph 14 of the Settlement Stipulation. The spreadsheet detailing the calculations underlying the five-year forward curve is included as EGU Exhibit 2. For informational purposes, Enbridge Gas has also included EGU Exhibit 3, which shows that during the 2024-2025 IRP year, 46.46% of the forecast demand for Enbridge Gas customers was supplied by Wexpro production.
