ISSUED: May 13, 2025

Pursuant to the Notice of Virtual Scheduling Conference issued on May 2, 2025, the Public Service Commission (PSC) held a scheduling conference in this docket on May 9, 2025. At the conference, the parties stipulated to a bifurcated schedule, which the PSC approves and adopts.

As the parties agreed, Phase I will address all issues necessary to determine Enbridge Gas Utah's (EGU) cost of capital, revenue requirement, return on equity, and will allow examination of EGU's depreciation study. Phase II will address cost of service among customer classes, rate design, continuation of EGU's conservation enabling tariff, weather normalization issues, and EGU's tariff proposals. The schedule, consistent with the parties' stipulation, shall be as follows:
