PRESIDING OFFICER: This is the public witness hearing in Docket Number 25-057-06, the Application of Enbridge Gas Utah to Increase Distribution Rates and Charges and Make Tariff Modifications. We have with us today Ms. Clark and Mr. Summers representing Enbridge and Mr. Moore here representing the Office of Consumer Services and also Michele Beck and two of her new technical consults. And from the Division this is --

MR. WHEELWRIGHT: Doug Wheelwright.

PRESIDING OFFICER: Doug Wheelwright. I knew that. Just had to jog my memory. But you don't have counsel here this evening. You're it?

MR. WHEELWRIGHT: I guess so.

PRESIDING OFFICER: More than adequate. That's great.

All right. Well, we will have a little better handle on the time this evening because we, in the notice, said that people who are here by 6:30 will have an opportunity to testify. So we have 25 minutes to see if anybody else shows up. We'll stay on the record for just another minute.

I want to correct one thing. Apparently I'm -- either my brain has gone haywire or -- I guess I wasn't reading this; so I guess I can't say that I'm

1 dyslexic, but I think I may have said Rule 804 Rules of
2 Evidence. I think after practicing law -- I haven't
3 practiced law since 2003, but after practicing the law
4 for 20 years, I would know it was Rule 408.

5 So I'm just going to state that on the record,
6 and we'll make a correction in the transcript this
7 morning -- which deals with settlement negotiations and
8 doesn't really deal -- it's not really a rule of
9 confidentiality, but it's a rule on -- on settlement
10 negotiations and discussions that are kept off the
11 record and not put on the record to protect the ability
12 of parties to have free and unfettered and open
13 discussion while they're settling -- attempting to
14 settle matters. So that's the reference that I should
15 have used this morning.

16 Having said that, I don't have anything else
17 on my mind that I'd like to wax eloquent on the record
18 about. So do any of you have anything you'd like to say
19 on the record before we go off the record and see if
20 anyone -- we'll go back on again at the very end. Does
21 anybody have any pearls of wisdom they'd like to share
22 with us this evening?

23 Okay. All right. Let's just go off the
24 record.


