17 Utah. I'm David Clark, one of the commissioners. Seated next to me is John  
18 Harvey, also a commissioner. We have representatives from the company,  
19 Enbridge Gas Utah, and also the Division of Public Utilities. And so far, we see  
20 no members of the public present to offer statements. For the record, we're at  
21 the Uintah Conference Center in Vernal, Utah. And a notice of this meeting was  
22 published in various ways some time ago. We noted in that notice that we would  
23 be present until 6:30 p.m. to hear the statements of any members of the public  
24 who desire to address the application. And so what I propose to do now is to  
25 adjourn temporarily and we will bide our time here for the next hour to see if  
26 anyone comes to address the application. I'll also note for the record that a  
27 settlement stipulation has been filed with the Commission that has no opposition  
28 that we know of currently and that involves most of the parties in the case  
29 affirmatively supporting the stipulation. We'll have an evidentiary hearing to  
30 address the application and specifically the settlement stipulation on  
31 Wednesday, October 22, that will start at 9 a.m. at the Commission Offices in  
32 the Heber Wells Building in Salt Lake City. So with that, we'll adjourn  
33 temporarily and await any public statements. Thank you.
