On August 29, 2025, Questar Gas Company dba Enbridge Gas Utah (EGU or the Company) filed an Application in the above-referenced docket (Application) seeking the Utah Public Service Commission's (Commission) approval to update the Daily Transportation Imbalance Charge and the Company's Utah Natural Gas Tariff No.700 (Tariff).

This Application included EGU Exhibits 1.09 and 1.10, which provided the combined legislative and proposed Tariff sheets reflecting rate changes in all dockets concurrently filed on August 29, 2025. Those dockets include the Company's Infrastructure Rate Adjustment in Docket No. 25-057-14, an Application to adjust the Conservation Enabling Tariff in Docket No. 25-057-15, an Application for an adjustment to the Daily Transportation Imbalance Charge in Docket No. 25-057-16, an Application to adjust Low Income/Energy Assistance rate in Docket 25-057-17, an Application to adjust the Energy Efficiency rate in Docket No. 25-057-18 and an Application to remove

the Sustainable Transportation Energy Plan (STEP) rate in Docket No. 25-057-19. On September 10, 2025 the Company submitted corrected exhibits in Docket No. 25-057-16, which included a correction to Transportation Imbalance Charge reflected in the combined legislative and proposed Tariff sheets. As such, the Company submits the corrected combined Tariff sheets reflecting this change as


