On August 29, 2025, Questar Gas Company dba Enbridge Gas Utah (EGU or the Company) filed an Application in the above-referenced docket (Application) seeking the Utah Public Service Commission's (Commission) approval to update the Daily Transportation Imbalance Charge and the Company's Utah Natural Gas Tariff No.700.

This Application included EGU Exhibits 1.1 through 1.5, which provided the updated transportation imbalance charge and accompanying legislative and proposed tariff sheets, as well as combined legislative and proposed tariff sheets reflecting rate changes in all dockets concurrently filed on August 29, 2025. Those dockets include the Company's Pass-Through application in Docket No. 25-057-13, an application seeking approval to adjust the Infrastructure Rate in Docket No. 25-057-14, an application seeking to adjust the Conservation Enabling Tariff (CET) amortization rate in Docket No. 25-057-15, an application seeking approval to adjust the Low Income/Energy Assistance rate (Low

Income) in Docket No. 25-057-17, an application seeking to adjust the Energy Efficiency rate in Docket No. 25-057-18 and the STEP Rate Removal in Docket No. 25-057-19.

In subsequent discussions with the Utah Division of Public Utilities (Division) the Company discovered that its original calculation shown in EGU Exhibit 1.1 included data from July 2024 through July 2025. The rate calculation mistakenly included 13-months of data instead of the most recent 12-months of data ended July 2025 as intended. The Company has corrected this error and removed the July 2024 activity from the rate calculation. This changes the calculated rate to \$0.07783, compared to the originally filed rate of \$0.07685. The Company submits the following corrected exhibits reflecting this change:
