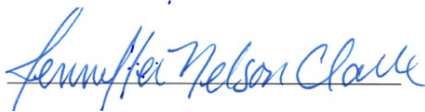
Questar Gas Company dba Enbridge Gas Utah (“Enbridge Gas”) hereby withdraws its Verified Application (“Application”) filed in this docket on September 3, 2025, without prejudice pursuant to Utah Admin. Code R746-1-205. No party has filed a responsive pleading to the Application. The basis for withdrawing the Application is to provide time and opportunity for Enbridge Gas to comply with Utah Admin. Code R746-440-1(2)(a) & (b). On September 10, 2025, the Commission vacated the previously calendared scheduling conference in this docket, pending Enbridge Gas’ compliance with such regulation. Accordingly, Enbridge Gas will proceed to provide the necessary public notice required by Utah Admin. Code R746-440-1(2)(a) & (b), and Enbridge

Gas will inform the Commission of the anticipated re-filing of the Application and the necessary details of the public notice. Once these required notices have been accomplished, Enbridge Gas will re-file an updated Application in this same docket pursuant to Utah Admin. Code R746-1-205.

WHEREFORE, Enbridge Gas withdraws its Application in this docket without prejudice, pending Enbridge Gas' compliance with Utah Admin. Code R746-440-1(2)(a) & (b), after which Enbridge Gas will file an updated Application within this same docket.
