VERIFIED APPLICATION

Pursuant to Utah Code Ann. 54-3-3 and Admin Code R746-405-2, Enbridge Gas Utah ("Enbridge Gas" or "Company") respectfully requests the Utah Public Service Commission's ("Commission") approval of the attached and updated Section 5.08 of the Company's Utah Natural Gas Tariff No. 700 ("Tariff"), effective June 1, 2025. The proposed changes update the Company's penalties when restrictions on daily balances are in place. If approved, the updated policy will be applied to all TSS, TSM, TSL, TBF, and MT customers through their respective agents.

The Company occasionally places restrictions on daily gas usage. During periods of restriction, the Company calculates an out-of-tolerance penalty by comparing customer supply to its actual usage and assesses the penalty to the customer through its agent. The current Tariff language is worded such that a customer may be able to pay less for gas by paying the penalty

than by purchasing gas and properly nominating volumes. The Company is proposing to change the Tariff language to remove this disincentive.

The Company is requesting an effective date of June 1, 2025, which will include this change in the upcoming winter heating season, when restrictions are most likely to happen. The Company does not anticipate that its request will take more than 30 days to implement, but remains flexible in the event that regulators need more time to determine the prudency of this request.

The proposed changes to Section 5.08 of the Tariff, are shown in legislative and clean format in the attached EGU Exhibits 1.08 and 1.09 respectively. This request is supported by the Direct Testimony of Mr. Steven Wall and the accompanying Exhibits attached as EGU Exhibits 1.0 through 1.09, all of which are incorporated herein by this reference. This proposed Tariff change does not constitute a violation of a state law or Commission rule, and approval of this application is just, reasonable and in the public interest.

Based upon the foregoing, the Company respectfully requests that the Commission approve the proposed Tariff change with an effective date of June 1, 2025.


